SYNOPSIS: [Your Honour,

On October 23, 2023, the accused Sean VON DEHN attended a court proceeding of a summary judgement hearing that he was personally involved in. During this proceeding VON DEHN audio recorded the proceeding and posted it on November 1, 2023, to his website www.vondehnvisuals.com. Above the audio link VON DEHN states "And as promised here is the audio from the Rule 20 motion hearing 23-10-23".

On October 23, 2023, in the court room the clerk specifically stated "you are not permitted to make any recording of the proceedings or take photos, or screen captures of the proceedings. It is an offence under section 136 of the courts of Justice Act and it may constitute contempt of court for anyone to copy, record, screenshot, photograph, publish, or broadcast a court hearing or any portion of it, or broadcast a court hearing or any portion of it, or otherwise disseminate such a record including on social media and/or other internet sites without express permission of the court".

Shortly after this is said VON DEHN states "I promised the court in other correspondences before this matter today that I would not record the proceedings today because opposing counsel was taking exception to the fact that I had done that previously. I have been publishing the audio of these recordings to my blog and I've asserted that I have the right to do that under Canada's Constitution which allows uninhibited recordings and public access to proceedings." He then goes on to say that he is rogue journalist, a freelance journalist and that it he believes its important to protect the inherent rights of Canada's people".

The court then reiterates saying "I am just going to reiterate that it is strictly prohibited to do any - to take any recordings, audio recording, and I am going to remind you that it is in the accordance with section 136 of the courts of justice act and section 136(4) of the justice act indicated that every person who contravenes this section is guilty of an offence and on conviction is liable to a fine of not more that \$25,000 or to an imprisonment for a term of not more than six months or to both. So, you are prohibited to make that recording and that is going to be maintained for the duration of this hearing".

VON DEHN agreed by saying "Okay"]

On November 8, 2023, the complainant Katie SHAW a security clerk with the justice Sector of the Ministry of the Attorney General reported a mischief. She reported that Sean VON DEHN recorded audio from a court proceeding and posted it online. SHAW advised that at the beginning of the proceedings the clerk advised that recording court proceedings was a violation of section 136 of the Court of Justice Act. Justice Marc Smith was presiding, and he reiterated that fact to the plaintiff, VON DEHN, who ignored the warnings and made an audio recording of the entire proceedings.

The recording was found posted on VON DEHN's website www.vondehnvisuals.com. It appears it was posted on November 1, 2023.

I did see that I had saved the web capture of the VON DEHN website and have a copy of the recording of the court proceeding that was recorded by VON DEHN during the summary judgement hearing on October 23, 2023, in court room 30. I obtained this recording off the the website https://vondehnvisuals.com/2023/11/01/22-89835-the-kingdom-of-heaven-found-a -sean-verses-johnson-et-al-rule-20-motion-hearing/ [vondehnvisuals.com].

From an email forwarded to me by SHAW I saw that the audio recording was noticed on November 2, 2023, by Counsel for the defendant. Email attached to the file.

I listened to the court proceeding and can confirm that on October 23, 2023, in the court room the clerk specifically stated " you are not permitted to make any recording of the proceedings or take photos, or screen captures of the proceedings. It is clear to see that VON DEHNS was recording the proceedings from the start and that although he had stated he promised not to record the proceeding he continued to do so and then posted it on his web site.

I checked VON DEHN on in house and see that he has a drug charge from 2018 and a couple disturbance calls but he has no conditions on CPIC.

I ran him on MTO and see that he had an Ontario driver's license that was suspended for unpaid fines in 2016. I noticed that on both his Ontario DL and the in the court transcript his last name is spelt VON DEHN not VONDEHN.

On March 31 at 10:58 hrs I tried to call VON DEHN to advise him to turn himself in and his phone number on in house was not in service. I search Canada 411 to see if another came up for VONDEHN and had no success. VON DEHN will be charged under the Courts of Justice Act for 1 count of TAKE OR ATTEMPT TO TAKE PHOTO/VIDEO/RECORDING CJA 136 (1) and 1 count of PUBLISH/BROADCAST/REPRODUCE PHOTO/VIDEO/RECORDING CJA 136 (1) (b).

I put out a broadcast with RPG to arrest advising VON DEHN could be released on an undertaking, attached to file.

I attempted to contact VON DEHN and his number is no longer in service.

The audio recording will be disclosed once file is complete. On April 27 at 10:42 hrs I attended 320 Via Chianti Grove to see Sean VON DEHN and release him on a undertaking.

VON DEHN answered the door and was given the opportunity to invite us in or deal with this in that hallway. He chose to have us stay in the hallway. I advised him who I was and that I was arresting and charging and releasing him for recording and posting his court proceeding in October going over the charge. He immediately stated "yes I did, it's my right" I advised him that I was going to read him his rights. I read his RTC and asked him if he understood and he said "yeah" "I don't require counsel". I read him his caution and he responded "yeah". I then read him his 425 warning and he stated "what does that mean" I advised him that if he was released from custody previously on any conditions that the crown can change /take away those conditions and have him held in custody. He then stated, "I'm not

As I went to go over the undertaking with VON DEHN he stated something like I'm not signing that, it's not a legal document my name is King Sean, you have to put King on the form. I asked him not to interrupt me and let me read through the form. He then asked if it was a promise to appear and I advised that it was similar it was an Undertaking. I provided him with the court date to attend and where and when advising that he may be able to do a zoom appearance. I went over the conditions that he needs to contact me if his address changes and that he also needs to attend for a fingerprint date providing the time, date and location. As I was going over the Undertaking VON DEHN stated, "I can read you can just give me the paper". When it came time to sign the form VON DEHN stated he would get his own pen and returned with a stamp pad placing his fingerprint where he was shown to sign. He stated, "I don't sign anything". I provided VON DEHN with a copy of the undertaking and went over a remote case management form leaving it with him.



According to him, the staff told him if he did not like it, he did not have to eat it. Sean could not recall everything he had said back but explained he had called the staff a "bitch". For that, as well as refusing to leave the kitchen when asked (please see the incident report by Kimberly Lovell for everything that transpired in the kitchen) I told him he would be discharged from the Life skills Program and TDA (temporarily denied access) to the Salvation Army Ottawa Booth Centre.

Sean left for a few minutes but when he returned he said he refused to be denied shelter at our facility and went upstairs to the 4th floor despite being told doing so would result in our need to call the police to have him removed.

Kimberly called the police while myself and Front Line Worker Peter Proulx went upstairs to talk to Sean, and observe in case his behaviour turned violent or destructive. Sean stayed in his room but eventually opened the door and was deciding if he would leave until my boss, Jason Prevost, arrived so he could speak to him. At approximately 7:50, Kimberly came upstairs with three Ottawa Police officers who arrested Sean after he refused to leave.

Kitchen staff Keisha and Corrine stated that he already touched the plate and had to use the plate that was given to him. Sean then proceeded to give the kitchen staff the middle finger and proceeded to sit down and eat his food. This writer asked Sean to please leave the building because verbally abusing staff is unacceptable behavior. Sean stated that he was not going anywhere until he speaks with Jason. This writer explained that speaking with Jason was not accessible at the current moment and due to his behavior, he was not welcomed in shelter. But I did not make any mistakes when filing the Claim, it is clearly marked as a Trust/Fiduciary obligation, so this Court has no excuse for failing to inherit the Jurisdiction required to provide Remedy under the Provisions afforded to these Courts by Canada's Department of Justice, 24.1, and the Trustee Act of Ontario is sufficient to provide these Courts (and therefore **any other officer representing these Courts in any capacity**) the **authority** to inherit the Jurisdiction required to allow the Trustee to fulfill his Fiduciary obligate Sean's in accordance with the **Trust Instrument** and Canadian Law.

I've set up a Special Page on My Blog where I Will be Publishing this Crown Investigate-Sean into Canada's Superior Courts, and I Will be sending his Majesty, King Charles III, a Letter with a link to the Page, and I Will be as King of Charles if he feels these Courts represent his Crown, and if he feels this Degree of incompetence and criminal conduct in Canada's Courts is acceptable. 


