Description

Ontario Works have been continuously spoliating (destroying, losing, or claiming to have never received) documents from the Beneficiary's case file, including a Trust Instrument and Declaration, a Mandamus for Health Care, and a Letter of Power of Attorney. I was also threatened with 'police action' for failing to destroy evidence of Kristine Haines-Chiarello's breach of Trust to another Beneficiary, sending Me another Beneficiary's request for an internal review when I was as King for proof of receipt of a renewal package for housing subsidy that was required to be filled out by Ontario Works in order to continue receiving the subsidy. They are also conspiring with 'Home for Good' to plead ignorance of a Trust Instrument, and cut of subsidy without Notice to Me and in violation of the Rule of Law with intent to have Me evicted for non-payment of rent, claiming I failed to return information packages they didn't send. They then characterize My behaviour as inappropriate and abusive for placing them on Notice for Breach of Trust with malicious intent. These crimes have been ongoing for six and a half years, the entire time first pleading ignorance of the Trust Instrument on file with their office, then finally (within the last six months) claiming that the Trustee Act is not binding on Ontario Works, nor is Canada's Criminal Code binding upon agents of Ontario Works for continuous spoliation of documents/evidence and malicious trespass upon My Trust and Spiritual obligations under threat of economic harm for failing to comply. Most recently, they have even weaponized the Ottawa Police Service against Me, threatening and harassing Me with a fraudulent undertaking and summons that was never filed with the Court or Crown, hoping to set up a 'mock' trials at the City of Ottawa with a mock judge so they could 'mock' arrest Me? I've reported these crimes to the police and they Will not even respond to My inquiries. I have also filed a claim against the City of Ottawa and Lisa Kilner has confirmed receipt and acknowledges that the Ontario Works administrator is guilty of several criminal breaches of public Trust, but has not responded to the Claim, not Honoured the default judgment, and is allowing these crimes to continue unabated. I believe this is collusion and conspiracy against Me, as they are also violating the Rules of Civil procedure arranging private 'ex-parte' motions with judges to have My claims dismissed without any documents ever being filed with the Court. Lisa Kilner was clearly advised that I believe she should be criminally liable in her personal, private capacity for failing to put an immediate stop to the criminal trespasses of the public Trustee for their malicious intent to trespass upon My Trust and Spiritual obligations.

They have recently served Me with a fraudulent summons and undertaking, neither of which the Crown has any Record of. There could be no more serious a breach of Trust than the 'lead hand' for the City of Ottawa allowing these outrageous crimes to continue on the premise that the Trustee Act of Ontario is not binding upon her. I believe Lisa Kilner is colluding with the City of Ottawa which is fraudulent use of public funds, and if she's not, she's demonstrating a serious degree of incompetence allowing the harm and trespasses against Me to continue.
