Dear Lisa,

This is EXACTLY the kind of incompetence and contempt I am accustomed to receiving from the City of Ottawa's administrator. You administer PUBLIC FUNDS, pay Your Self \$102,137.01 per year from the public Trust account, and don't have anything to say about the Ontario Works administrator suggesting they are not subject to the Trustee Act of Ontario and can trespass upon the Trust obligations with malicious intent because they are 'ABOVE THE LAW'?

And You expect to convince a Court that Your negligence in responding to this Claim is not escalating the claim and further aggravating the situation?

Dear Lisa,

It's 6:15 on a Friday evening. I'd advised You that I believe You are entirely responsible for the criminal trespasses of every single 'State Actor' or government employee working for the City of Ottawa, because You are the one responsible for receipt of the Claim in Your personal capacity, and You has thus far not so much as lifted a finger to put the criminal trespasses against Me by the Ontario Works administrator to a stop! The Trustee Act of Ontario applies to all Trusts whenever Created, and all Trustees whenever appointed.

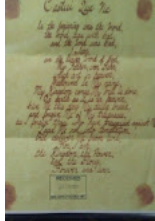

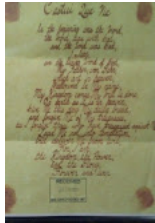
