Dear Prosecute-Sean for Crown,

Please note that as I have been unable to obtain ANY disclosure related to the attached SUMMONS and UNDERTAKING Presented to Me by the Ottawa Police Service, I have filed a Notice of Appearance requesting a trial so that I can Present evidence to a competent judge, as I believe the Ottawa Police Service are engaged in fraud with malicious intent to intimidate and harass a Trustee with a Trust Claim before the Superior Court of Justice despite the fact that I have reported to the Ottawa Police Service that opposing counsel in the Trust Claim (22--89835, The Kingdom of Heaven vs. Johnson et al) are engaged in serious federal offenses, including (but not limited to) interfering with Justice, insurance and court fraud valued over \$3 million, Estate fraud, and continuous contempt of Court, privately petitioning officers of the Court in violation of Rule 1.09.

Default Judgment has been awarded against opposing counsel in the Trust Claim, and the Court REFUSES to respond to correspondences of any kind and has not updated the Court Registry related to the Trust Claim since June 12th, 2023. They are 'faking' Court proceedings by filing documents with the Court, having clerks Sign the documents, then setting up Court hearings where there is no official Record on the Registry.

These are serious, indictable, federal offense involving multiple high ranking officials of the Court, and now I feel the City of Ottawa is weaponizing their police force against Me for attempting to hold clerks of the Court and their officers accountable to the Rule of Law in a Judicial proceeding before a Superior Court of Justice.

I Will further add that I do not believe that the Provincial Court has the Jurisdiction or Authority to interfere with a Matter before the Superior Court, and would like to request a Court of competent jurisdiction capable of inheriting the jurisdiction necessary to provide relief and remedy to the Claimant in accordance with the Provisions afforded to the Court by the Department of Justice and MOJAG under 24.1, 'Provisions of the Court'.

Please find relevant documents I intend to Present to the Court as evidence attached to this email.

Please also be advised that I have received correspondence related to this Matter from fraudulent email addresses 'impersonating' this office (Prosecution for Crown Attorney, 'Virtual Crown'). The fraudulent email addresses I have received correspondences from are:

I am only Trusting the email address for Crown provided for by the Minister of Justice and Attorney General according to the attached pdf.

It is absolutely ridiculous that I am reporting indictable, federal offenses to a Superior Court of Justice and NO ONE is lifting a finger to apprehend the criminals? I don't have to prove a thing because the Registry shows that no One has been appointed to represent My father's interests in any official Court proceeding TO THIS DAY the Registry shows My father is 'UNREPRESENTED'.

Just do a court case search for 'Joachim (Heinrick) von Dehn'.







This Notice of Appearance is to ensure I am not unlawfully arrested for failing to appear for a Court proceeding Crown Attorney has no record of according to the Court Case search database and the correspondences I have previously received from this office.
