## Notice of Crown Liability: Fraud and Trespass

Dear Vinicius,

This is a duly served Notice of liability served upon the Crown Law reception office and Vinicius Oliveira in his personal, private capacity as a 'CROWN' prosecutor for prosecutorial misconduct with MALICIOUS intent for attempting to weaponize the Courts against Me when I am complaining to the Court and the Crown Law reception office of FRAUD regarding the Estate of Joachim Heinrich von Dehn who still appears to be 'UNREPRESENTED' on the Court of Record, though several claims were 'discontinued' on January 3rd, 2024, and had been proceeding against My UNREPRESENTED father in the Toronto Superior Court, with Michael von Dehn receiving documents 'in care of' Joachim Heinrich von Dehn.

My sister is currently walking around with a FRAUDULENT certificate of appointment of Estate Trustee in an attempt to cover her fraud, selling the property under power of sale without any judicial oversight and stealing My rightful share of inheritance.

Furthermore, all of these claims are a very serious trespass upon a Trust Instrument on file with Canada's MOJAG (see link) which was specifically Created to Honour a Promise I made to My late father to protect the Estate from a grifting stripper claiming to have a 'Will' naming her as the Trustee and Executor.

Tiffany Singh is also responsible for the \$3 million in claims which My father has been held liable for by proceeding against the Estate in default without any legal representation.

This FRAUD involves THREE Superior Courts - the Bracebridge Superior Court, the Toronto Superior Court, and the Ottawa Superior Court whose clerks are conspiring with these liars posing as lawyers to keep the Estate off the private record with MALICIOUS intent to deprive both Me and My late father of Our right to due process.

No One has the right or the authority to trespass upon a Trust Instrument, including Superior Court Judges.

"The Powers, Rights and Immunities conferred by the Trust Instrument are in addition to those afforded by the Trustee Act of Ontario which has effect subject to the terms and conditions of the instrument creating the Trust."

I am as King for no less that \$1,000,000.00 in personal liability against the performance bond of Vinicius Oliveira who is a Crown prosecutor and knows (or ought to know) that he is engaged in fraud and trespassing upon a Trust Instrument. (A representative of the Crown cannot claim instrument of a Trust on Record with the Crown he allegedly represents).

Vinicius Oliveira is trespassing upon a Trust Instrument, My Trust obligations, and appears to be ignoring My complaints of serious criminal misconduct on the part of officers of the Court, while attempting to weaponize the Courts against Me for reporting the crimes and refusing to accept a decision obtained in fraud in the Civil Claim CV-22-89835.

It is also unreasonable and incorrect to suggest that Vinicius does not know that none of the information he has served upon Me and intends to use as evidence in his prosecution has been approved by any Court Justice (the Crown).

Vinicius Oliveira is hereby on Notice of Civil and Criminal liability for trespass with malicious intent to harass and intimidate a claimant before the Superior Court of Justice.

I Will rescind all claims against Vinicius Oliveira if he notifies the appropriate authorities of the Court and holds the criminals conspiring against Me and My late father to account. Failure to do so Will result in commercial liability in the amount of one million dollars, and Vinicius Will be subject to the fullest extent of the law for aggravated criminal malfeasance.

A prosecutor should (presumably) be prosecuting criminals, not Trustees reporting federal crimes to clerks of a Superior Court of Justice.

I am also as King for this email to be reviewed by the trial coordinator, Sally A. Gomery who I believe knows My siblings have been conspiring against Me for a considerable amount of time, and I don't believe My requests to investigate My non-acceptance of Marc E. Smith's decision for fraud has been reviewed by the trial coordinator because the Ottawa Superior Court is complicit in the fraud and colluding with the Toronto and Bracebridge Superior Court clerks.

I do not need to prove My claims against You, the Court of Record still shows My father is UNREPRESENTED and Jove Ponniah, supervisor of the Toronto Superior Court can provide all the claims that have been proceeding against My father in default, filing fraudulent affidavits of service on a fake address and a deceased person.
