Dear Beth Lambert, Director of Investigations for the Ombudsman for Canada Post.

You are hereby on Notice in Your personal, private capacity for engaging in Canada Post mail fraud, and for colluding with the City of Ottawa to produce fraudulent receipts of service of documents that were not served.

To this day, the 'public Record' (Your own Records) are in direct conflict with the findings of Your so called 'investigation'. Kelly Kritsch from the City of Ottawa claimed that she only Signed for Me to Show the package was returned to her - but that's not what the RECORD says - the RECORD says the documents were delivered to Me, redirected to Me, and Signed by ME - TWICE!!! That is FRAUD by definition.

The fraud also relates to identification and a Trust Instrument on file with Canada's MOJAG. You DO NOT have any right to plead 'ignorance' of a Trust Instrument of file with the Crown Attorney's office as a representative of the CROWN!!! You are also guilty of breach of Trust, and coveting documents I am rightfully entitled to receive in My Sui Juris capacity as a Sovereign Canadian People.

If You do not press charges against the City of Ottawa's 'D. Cote' and Kelly Kritsch for impersonating Me by fraudulently Signing for My documents, You Will be charged in Your personal, private capacity for gross criminal malfeasance causing harm, and or malicious intent to engage in fraud.

Alternately, You can concede that the Signature obtained was obtained in fraud on the 23rd of March, Signed by the sender before the package was even processed for delivery (as clearly demonstrated by the Signature on file and attached as evidence, 'exhibit B'), apologize for wrongfully defaming My character based on hearsay allegations provided (presumably) by the criminals You were tasked with investigating.

It seems very suspicious to Me that You would claim that the Signature was only obtained to show the package was returned to the City on June 14th when Your own Record shows the Signature was obtained on May 23rd, twenty one days before You are suggesting the package was returned to the City of Ottawa, and DESPITE the fact that the official Canada Post Record continues to Show that the package was redirected to My 'new address', and claims that I Signed for it.

I understand that the Canada Post 'Act' absolves the corporation from liability resulting from mail not received, but it does NOT absolve individuals war King for Canada Post engaged in criminal conduct and the production of fraudulent receipts pertaining to service of documents by Way of Registered Mail. You are STILL publicly claiming I received this package, and the receipt can be used against Me by the city of Ottawa to (fraudulently) claim they were not negligent, and served Me with the documents, producing Your fraudulent receipt as 'evidence'. That is FRAUD - an indictable, federal offense.

The Canada Post Act does not allow for agents war King for Canada Post to engage in criminal conduct, and any agent or investigator who supports, endorses, or conspires to engage in fraud, is subject to Canada's Criminal Code just as any One else would be. As a public servant, You are required to be bonded to ensure performance, and You are required by Law to advise Your insurance provider that there is now a claim on Your bond in the amount of \$1 million (one million dollars) for gross criminal malfeasance and fraud.
