NOTICE OF NON ACCEPTANCE FOR FRAUD and REPORT OF FEDERAL CRIMES AND PERJURY IN AFFIDAVIT MATERIALS WITH MALICIOUS INTENT TO INTERFERE WITH JUSTICE AND TO PERVERT THE RULE OF LAW.

Marc E. Smith's unacceptable decision was obtained by Way of fraudulent testimony made to the Court by opposing counsel suggesting that Tanja Johnson has been 'duly appointed by the Superior Court' as the Estate Trustee for Joachim Heinrich von Dehn. They make NO MENTION of the \$3 million in insurance claims proceeding against the Estate of Joachim von Dehn which are being served upon Michael von Dehn 'in Care of' Joachim Heinrich von Dehn. They have consequently proceeded against the Estate in default, wrongfully accusing My father for the criminal acts of Tiffany Singh who was responsible for a serious hit and run incident in Toronto.

If these claims proceeding against My father are unknown to You, it would not surprise Me because Jove Ponniah has been conspiring with clerks of the Toronto Courthouse to keep these claims off the public Record by not PROCESSING the documents they receive onto the REGISTRY - exactly the same crime clerks of this Ottawa Courthouse are guilty of - there is no record of this hearing or any of the hearings and events that took place preceding it. No documents received

by the Ottawa Courthouse related to this Claim have been PROCESSED onto the REGISTRY since **June 12th, 2023!!!**
THAT IS FRAUD AND BREACH OF TRUST!!!

Tanja and Michael **both** had full knowledge of all these claims at the time Tanja made both applications and are fully aware they are keeping this information from the Court. They have lied to EVERY Court Judge to whom they have made an application, outright LYING about the \$3 million in insurance claims they have been allowing to proceed against My father in default without any judicial oversight so that they could sell the house (without any judicial oversight under power of sale) and deny Me (or any other interested party) his right to participate in the application process.

Jove Ponniah, Carrie Thompson, and Krystal Johnson have been placed on Notice for Civil and Criminal Liability for colluding with liars posing as lawyers to deprive entitled parties of their right to participate in a PUBLIC hearing, and for all interested parties to receive Notice of Matters concerning their interests.

All clerks of this Court (the Ottawa Superior Court of Justice) have also been placed on Notice for Breach of Trust, Trespass upon a Testamentary Instrument on file with Canada's MOJAG, and for pleading ignorance of Trust Law, the Powers, Rights and Immunities of Trustees to fulfill their fiduciary obligations, and the Trustee Act of Ontario.

Please find attached the \$3 million dollars in claims proceeding against My father which I was only able to obtain AFTER placing Jove Ponniah (Supervisor for the Toronto Superior Court of Justice) on Notice of liability for his participation in the fraud and allowing claims to proceed against an unrepresented dead Man and the rightful beneficiaries of his Estate.

Myriam, You are going to provide Your last name, please. You are going to press criminal charges or forward this email to the trial coordinator, Sally A. Gomery. This is a TRUST Claim, and I Will not have any additional clerks pleading ignorance of the Rule of Law and the Trustee Act of Ontario.

All conspirators were noted in Default for their fraud, and the default judgment awarded against them is binding. If You Wish to conspire with the clerks of this Court to trespass upon My Trust obligations and support the fraud, You Will be added to the list - it is long and growing.

If You DO NOT Wish to be added as a conspirator to the fraud, conspiring with clerks of this Court to keep Matters OFF THE PUBLIC RECORD, You Will forward this email to the trial coordinator, Sally A. Gomery so I know that My non-acceptance for fraud has been accepted and added to the official Court of Record.

When I report federal crimes to You, You have a legal and lawful obligation to investigate, and to advise the trial coordinator of My concerns. You are hereby Given Notice of these facts.

If I do not hear from Sally A. Gomery directly that criminal charges are being laid for the very serious crimes perpetrated against Me and My late father, and if the default judgment awarded against all the guilty parties (My due process of service of the notices witnessed by this impartial court) is not enforced, You Will be added as a conspirator to the fraud and liable to Me for an additional \$1 million.

You can speak with Krystal Jones who has agreed to accept full civil and criminal liability for denying Me a Court of COMPETENT jurisdiction necessary to enforce My Trust obligations as a TRUST Claim, for refusing to provide Me with a transcript I was ordered to receive by Justice Somji in the adjournment hearing, and for failing to process any documents onto the REGISTRY related to this Matter since June 12th, 2023.

I am tired of GASLIGHTING. You Will answer My questions, or You Will be charged to the fullest extent of the Law. It is not believable for clerks of a Superior Court of Justice to plead ignorance of a Trust Instrument, or the Trustee Act of Ontario.

The Judge is engaged in fraud, the court of record STILL shows no documents have been processed by the Bracebridge Court since March 24th, 2022 - there is absolutely no Record of Tanja Johnson being appointed as Estate Trustee by any Court in the province of Ontario. Judges do not have the luxury of IGNORING or PLEADING IGNORANCE of what the Court knows as an impartial body.

You are hereby on Notice of Civil and Criminal liability if I do not hear back from the trial coordinator confirming receipt of this email. You don't have the 'luxury' of ignoring My complaints to You about criminal conduct taking place in Your courts.

I Will need You to confirm receipt of Notice of Liability in Your personal, private capacity, and I require Your last name for the purpose of litigation.
