Fraud. \$3 million in insurance and estate fraud, trying to convince Me that My sister, Tanja Johnson was awarded a Certificate of Appointment of Estate Trustee for the Estate of Joachim Heinrich von Dehn in violation of My Trust instrument on file with Canada's MOJAG to protect the Estate, and while at least a dozen lawyers are proceeding against the estate in default, wrongly accusing My father for the criminal acts of Tiffany Singh, who is colluding with My siblings to keep the estate off the record so that the insurance can pay for her crimes against My father, and she can take the remainder funds from an unlawful power of sale.

There has been no judicial oversight regarding ANY of these matters because the lawyers are colluding with clerks at the Toronto, Ottawa, and Bracebridge Courthouse to keep matter 'off the Record' because there is a Trust Instrument on file with MOJAG which does not allow any claims to proceed against Me or My father without Notice to Me.

I reported the crimes to the Ottawa Police and they instead tried to arrest Me for recording the proceedings (which is the only evidence I have to prove the fraud because there is no 'public record' of the hearing because they are not 'processing' documents onto the Registry.
