Good morning, Lisa 'the colluding' Kilner,

Dear King Sean, House von Dehn:

The purpose of this email is to follow up on your notices of claim and your notice of default judgement in relation to alleged breach of trust on the part of City of Ottawa staff. In particular, we wanted to follow up formally on claim submission in May 2024, per your recent request. My apologies for the delayed response on behalf of the City's Claims Unit.

The basis of your claim appears to stem from your belief that the *Ontario Trustee Act* applies to your Ontario Works benefits and your perceived breaches of the City's obligations thereunder in the City's capacity as Administrator under the *Ontario Works Act*.

In reviewing your file and the above concerns with Legal Counsel and operational staff, I must advise that the City is unable to offer compensation for the costs you are seeking as there is no legal liability on the part of the City of Ottawa.

By way of background, in assessing claims for compensation, the Claims Unit must determine if the City is legally responsible for the damage or loss that has occurred. This approach ensures fair and consistent treatment of claims. It also considers the interests of claimants and the City's responsibility to all taxpayers, bearing in mind that claims are ultimately paid with public funds. The City cannot be held responsible for any costs unless evidence is provided that the City committed a negligent act or omission in its operations which resulted in the alleged damage or loss related to the property. In cases where the City finds there is no legal liability on its part, as is the case here, the Claims Unit is unable to make any payment.

In view of the above, there is no evidence of legal liability on the part of the City. I appreciate this is not the answer you were seeking in this matter, however, as we have responded to this matter and notice of claim, we will not be responding to future complaints or notices of claim about this same issue.

We understand that you remain unsatisfied and regret this to be the case.

Lastly, I note that you have repeatedly indicated that you intend to take legal action regarding this matter. I would encourage you to obtain independent legal advice to understand your options in this regard.

A copy of the Trust Instrument is also on file with Ontario Works (if they haven't destroyed another copy).
