Here is the information that was provided by the Ministry:

Thank you for sharing the concerns of your constituent Sean von Dehn, also known as King Sean, House von Dehn, regarding civil and estate proceedings and for providing the attached written permission to discuss the details of your constituent's files.

There are five civil and estate court proceedings in the Superior Court of Justice which pertain to the inquiry:

- CV-20-000639418-0000, Toronto Superior Court of Justice
- CV-20-000638907-0000, Toronto, Superior Court of Justice
- CV-20-000634159-0000, Toronto Superior Court of Justice
- CV-22-00089835-0000, Ottawa Superior Court of Justice
- 2020-59, Bracebridge Superior Court of Justice

In carrying out their duties, court staff are guided by and act according to applicable laws, ministry policies and procedures, and at the direction of the judiciary, as set out in the *Courts of Justice Act*. Civil proceedings in the Superior Court of Justice are governed by the *Courts of Justice Act* and *Rules of Civil Procedure* and estates proceedings are governed by these rules and legislation as well as the *Estates Act*. Concerns or arguments about the application of the law, including procedural law, may be raised with the Court for judicial consideration in accordance with the appropriate court rules.

Your constituent's email refers to the hearing before the Honourable Justice Marc Smith in the Ottawa Superior Court of Justice, related to court file no. CV-22-00089835-0000. Your constituent specifically expresses concerns about the validity of the Certificate of Appointment of Estate Trustee issued by the court to his sister, Tanja Johnson. As set out in the decision of Justice Smith dated November 1, 2023 the claims made by your constituent (the Plaintiff) against the Defendants in the proceeding were dismissed in their entirety, including his allegations of fraudulent conduct.

Judges are accountable for their decisions through the appeal process and through judicial complaint procedures. If your constituent wishes to appeal any orders made by a judge, they should be aware that there are timelines involved and may wish to speak to a lawyer about their options for appeal.

The Law Society of Ontario (LSO) runs the Law Society Referral Service (LSRS) for individuals who need assistance with a legal matter. Through this service, the LSO can provide your constituent with the name of a lawyer who will provide a free initial consultation up to 30 minutes to help determine their rights and options. If your constituent decides to retain a lawyer, their normal fees and disbursements would apply. The LSO also maintains a directory of its licensed professionals in Ontario through its Lawyer and Paralegal Directory.
