King Sean,

I have read all of the emails you sent. What normally happens when councillors receive emails like yours, where city services staff need to be involved, is that we forward them on to staff. As councillors cannot

become involved in the day-to-day operations of the City and its services to individuals (especially where there are funds involved that would directly benefit a resident) due to conflict of interest legislation, we do not become involved, despite the fact that we feel for the resident who needs help.

The main help we provide is to ensure that staff are aware and have confirmed that they are reviewing the situation. That has happened. The one other thing that might be helpful for you to know is that councillors do not involve themselves in helping residents who do not live in their ward. Again, that is not because we don't want to help. It is because we respect the work of our fellow councillors to help the residents of their ward, without interfering.

I am sorry that you perceived my lack of answer as anything other than our regular process. Know that your emails have been sent on to city staff to engage them to help you. I am not clear on what ward you live in, but I don't believe you live in Kanata North? Let me know if I am wrong. And, depending on where you do live, I could engage your ward councillor.

Dear Cathy Curry,

Thank You SO much! I tell People I'm really not so hard to get along with, and I Promise You it is True. Although I clearly comprehend every Word of Your email to Me, I am going to push back as gently as I can while strongly asserting that it was incorrect and unreasonable for You to wait so long to confirm receipt of My complaint. If You had sent Me the above email the same day I had contacted Your office and spoke with Sheila, I would have been very satisfied.

In response to Your other issues regarding the constituency, Wilson Lo is in fact the councillor for the ward I am currently sojourning in, but I also believe he was responsible for as King of the landlord to have Me evicted for 'inappropriate behaviour' for as King of Wilson Lo why Ottawa's Public Health were coercing tenants into receiving the Covid vaccine, falsely selling the product as a 'safe and effective'.
