Good morning every One!

Every One in receipt of this email is a public servant for the City of Ottawa in varying capacities. We have journalist Arthur White-Crummey as an impartial, public witness to the criminal acts of the public Trustee for Ontario Works and their manager, Clara Freier.

Nana Asante revoked a portion of medical benefits without cause or Notice to Me - that is a CRIMINAL offense! Criminal MALFEASANCE if it is an ERROR. An ERROR would be corrected IMMEDIATELY. If the ERROR is not fixed immediately, then the criminal Act is considered willful (malicious, with criminal intent to cause harm), or 'mens rae'.

I have just proved by Way of her own email to Me that medical benefits are **NOT TO BE REVOKED FOR ANY REASON WITHOUT NOTICE TO ME UNTIL MARCH 2025!!! (SEE BELOW)**

Your file required an update of your medical transportation form, because of this you were not issued funds for this month.

I have extended your medical transportation allowance and have issued you the funds onto your Reloadable Payment Card.

If there are any changes to your circumstances, please let me know. **If not, your special diet and medical transportation forms are valid until March 2025.**

If you have any further questions, please do not hesitate to contact me.

I have just PROVED that revocation of medical benefits was UNLAWFUL and UNWARRANTED. My Benefit forms are valid until March 2025, so this is also a **breach of contract with malicious intent!!!**

If not done with malicious intent, what is the delay, Nana? Why did You not IMMEDIATELY correct Your error the moment it was made known to You?

And why are OTHER AGENTS now as King of Me to provide proof of entitlement to benefits when I have a contract that says You have all the benefit forms necessary and do not require them to be renewed until March 2025? It's because You

Wish to threaten Me with further economic harm for calling You out for revoking My benefits with malicious intent to cause Me harm!

This is the THIRD time SINCE the Tribunal hearing where Brian Killick acknowledged that Ontario Works had revoked benefits entirely unlawfully, even according to the Ontario Works Act it Self! Clearly, the fact that the Tribunal cannot penalize public servants for their criminal acts allows them to believe they can perpetrate these crimes against Beneficiaries with impunity because there is absolutely no consequence for Nazi Nana, right? Brian Killick, vice chair for the SBT has been invited to this email as witness of Your latest crimes and verify these facts. I'm sure he Will be happy to provide You with a copy of his decision.

Caroline Forget took it upon her Self to award what she believed was correct, rather than what the Tribunal ORDERED her to repay Me. Only AFTER cc'ing Brian Killick of the SBT and advising him that I would be holding him liable if they did not put the correct amount ordered to be paid into the Beneficiary's account did the correct sum finally get paid! They have ABSOLUTELY NO RESPECT FOR THE RULE OF LAW OR THE PEOPLE THEY WERE TRUSTED TO SERVE!!!

Now, after two weeks of NO REPLY from any One, **including general manager, Clara Freier** who Gifted her Self with a **12.3% increase** so that she now receives a whopping **\$213,320 per year** (though I'm sure You are probably giving Your Self another raise for doing such a stellar job this year). I find it amazing that there is so much money to pay these outrageous government salaries to public Trustees but not enough money in the public Trust to Give the Beneficiaries You were Trusted to care for sufficient wealth for human dignity? And You Give Your Self a raise? On what grounds? What did You do 'well' for Canada's People? What did You do to lift People out of poverty in the City of Ottawa, Clara? Trespassing upon My Trust obligations and holding Me in bondage, trying to convince Me that I am entirely dependent on You for My most **basic subsistence**?

"In no case shall a People be deprived of its own means of subsistence." U.N. Covenant on Civil and Political Rights ratified by Canada in 1976 (March).

Should You also be charged with engaging in bondage and slavery? How long do You feel is reasonable to respond to an urgent message from a Beneficiary subject to harassment and economic abuse by one of Your agents? You haven't responded to Me yet, Clara. Why do You believe You are not subject to the Trustee Act of Ontario? Why is Canada's Criminal Code not binding upon You for the harm You are doing to Me by Way of Your trespass with malicious intent?

You have two city liars posing as lawyers invited to witness this email exchange. How long before You fix Your error and stop tormenting the Beneficiary and subjecting him to Your economic exploit a Sean? How much compensation is One subject to Ontario Works abuse entitled to? What is reasonable for stealing six years of My life for no other reason than Your claim that the Trustee Act of Ontario does not apply to Me or You? Where do You come up with that belief, Genevieve? Let's face it - not a reasonable argument, You have been aiding and abetting their crimes and interfering with justice by enabling these criminals.

I look forward to hearing from You. At \$213,320.00 a year salary, One would be thing King that You (Clara Freier) should have sufficient intelligence to respond to Me and answer My questions. Or do You hope to gaslight Your Way to victory? Why should You not be charged to the fullest extent of Canadian law for Your malicious breach of the public's Trust and the contempt for the Rule of Law demonstrated by Your case workers?

Did You expect Clara Freier to double down and threaten to revoke the remainder of My benefits for reporting her crimes to You? I included the above form from Nana Asante to PROVE there is no legitimate requirement for Me to submit forms, this is what they do to threaten People with economic harm for complaining about their abusers.
