Good day, Honourable Minister, Michael Parsa,

I Wish for You to know that Clara Freier has indicated to Me that neither she, nor any of the agents she oversees as manager of Community and Social Services for the City of Ottawa, are subject to the Trustee Act of Ontario or Canada's Criminal Code for trespass upon a Trust Instrument with malicious intent (a criminal offense subject to up to fourteen years in jail - not taking into account 'aggravated circumstances' if the harm is done by a Trusted public servant).

Clara Freier also seems to believe that she may spoliage (lose, destroy or plead ignorance of) documents and contracts her office has Signed with Me, promising to Honour the Trust Instrument, so that she may continue her trespasses against Me with impunity.

They unlawfully revoked medical benefits without Notice to Me for a period of longer than five months. My optimal, healthy weight is 135lbs - I weigh less than 115lbs as a result of the economic exploitation I have been subject to at the hands of tyrannical, treasonous 'manager' and public Trustee, Clara 'the Criminal' Freier.

I believe that ultimately, the regional managers for the Ontario Works Act have a moral and ethical obligation to report to You and to advise You when the Benefits provided to Beneficiaries are insufficient to provide for basic human dignity. There is insufficient wealth in the public Trust to provide the People You were Trusted to care for the resources necessary to provide for basic human dignity, but You can pay the manager, Clara the Criminal Freier \$213,320.00 (2023, I'm sure You've been generous enough to Give her ANOTHER 12.3% increase this year) annually? Where is that money coming from if You don't have sufficient wealth to provide Canada's People with basic, human dignity? Is that not extortion and exploitation of the People's money by definition?

I'd love to know Your thoughts on this. Should I include Your name in My application to the Divisional Court for Judicial Review? The Divisional Court accepts Applications when it is found that a Trusted public servant makes a determination that is patently 'incorrect or unreasonable'.

It seems both 'incorrect and unreasonable' to Me, that You have plenty of wealth in the budget to provide six figure salaries to public Trustees, but insufficient wealth to provide

Canada's People with the resources necessary for basic, human dignity?

What exactly is the 'basic needs' portion of Ontario Works supposed to cover? Hyrdo, internet, phone, rent, food, health and dental care are all basic needs that You have a fiduciary obligation to provide to Canada's People.

Any of these forementioned financial obligations belong to the government, the 'Trustees' of the People, 'Trusted' to Act in the People's best interest, not to weaponize the Ontario Works Act against Canada's Beneficiaries, threatening them with further economic exploitation and undue psychological and emotional harm for failing to allow the public Trustee to violate their Charter rights with impunity.

Clara Freier has failed to explain to Me why the Trustee Act of Ontario and Canada's Criminal Code do not apply to her. Perhaps You can provide an explanation? Or is this considered 'acceptable' conduct for a public Trustee and worthy of 12.3% increase?! For what, exactly? Exploiting Canada's People with extreme prejudice, holding them in economic bondage to the state? Is that what she gets paid so much money to do? Your technically her boss, right?

So as far as I'm concerned, You need to have a very serious chat with Clara Freier to put these trespasses to a stop immediately, or I Will have no choice but to charge You with aiding and abetting her crimes as the Minister of Community and Social Services.
