Breach of trust is an offence under Section 122 of the Criminal Code of Canada. This section makes it a criminal offence for a public officer to intentionally and knowingly commit an act that violates the duties of their office or position of trust, for the purpose of gaining a person benefit or causing harm to another individual or institution.

Section 122 of the Criminal Code states that everyone who:

Every official who, in connection with the duties of their office, commits fraud or a breach of trust, whether or not the fraud or breach of trust would be an offence if it were committed in relation to a private person, is guilty of

(a) an indictable offence and liable to imprisonment for a term of not more than five years; or

(b) an offence punishable on summary conviction.

Section 122 is a dual/hybrid offence, which means the crown prosecutor can proceed by summary or by indictable offence.

I think this would qualify as indictable because You are doing it with malicious intent to breach the Trust and cause Me emotional and economic harm.
