I've had an opportunity to review the several emails you have sent to various government and court departments this week. I will not be addressing empty allegations or getting into any form of substantive litigation via email (that is what the trial is for).

Your matter was set for a *trial in absentia* pursuant to the provisions contained in the governing legislation, *Provincial Offences Act*. Criminal breach of trust

336 Every one who, *being a trustee of anything* for the use or benefit, whether in whole or in part, of another person, or *for a public or charitable purpose*, converts, *with intent to defraud* and *in contravention of his trust*, that thing *or any part of it to a use that is not authorized by the trust* is guilty of **an indictable offence and liable to imprisonment for a term not exceeding fourteen years.**

R.S., c. C-34, s. 296
