Dear 'Crown' for the Province of Ontario (Ontario Provincial Courts of Justice),

"This inbox is only for acceptance of service of electronic documents relating to *urgent matters for the Public Prosecution Service of Canada offices located in Ottawa* and Kenora during the COVID-19 pandemic. This AutoReply is confirmation of receipt of your email." - Your most recent email to Me...

I require full disclosure of all hearings and endorsements related to the two above listed case file numbers ASAP! I understand this is not Your fault or error, but I need this Matter dealt with immediately. These are very serious criminals conspiring against Me and (very frankly) impersonating YOUR office. These City of Ottawa employees engaged in fraud allegedly represent the Ontario Court of Justice. I'm hoping You Will prove to Me they don't.

For Matter 23-353404, Vincius the Odious Oliveira and Yvonne the Grifting Goebel have scheduled *a trial hearing date* for Tuesday, March 11, 2025 at 100 Constellation Drive, Ottawa, Ontario.
