Good morning, 'the City of Ottawa',

ALL CITY COUNCILLORS FOR THE CITY OF OTTAWA, PLEASE TAKE NOTICE OF CIVIL AND CRIMINAL LIABILITY: BREACH OF TRUST, RACKETEERING, EXTORSION, FRAUD, COLLUSION AND CONSPIRACY TO ENGAGE IN FRAUD TO PERVERT THE COURSE OF JUSTICE, AND TREASON AS REPRESENTATIVES OF THE PEOPLE AND HIS MAJESTY, CHARLES III.

I regret to inform You that the Criminal Organization You have set up at the Ontario Superior Court (which I have elected to Call 'the Kreling Crime Syndicate') has officially been infiltrated and exposed.

I noticed that You have staffed the Ottawa Superior Court with City of Ottawa employees who are more interested in protecting the Kreling Crime Syndicate than they are in ensuring Ottawa's People have access to Justice. In fact, their job specifically appears to be intercepting any claims or motion materials that may compromise the City of Ottawa's criminal operation.

Of course, I tried to report this to the local police but it appears You have infiltrated and compromised the entire department. Apparently, reporting Your federal crimes and racketeering operation is a criminal offense in the City of Ottawa and the police Will impersonate the Crown Attorney's office by conspiring with corrupt individuals like Herb the Criminal Kreling who Will impersonate a Justice of the Peace and proceed against individuals privately 'off the Record'.

City of Ottawa employees have been 'programmed' to tell any One who calls the Virtual Crown Ottawa office (the official office for MOJAG) that they can't find any 'public Record' of their charges because the City of Ottawa is *not required to process information onto the Registry* if they are proceeding against an individual in the City of Ottawa (Patrick Emard, City of Ottawa). I have a recording of Our phone call and when I advise him that it is NOT okay to not process documents onto the Registry and for there

to be no 'public Record' of the charges, *he hangs up on Me!* So obviously, Patrick Emard is in on the grift and part of Your not-so-little province wide criminal network.

City of Ottawa liars posing as lawyers meet with Justices in violation of the Rules of Civil Procedure ROUTINELY to request for claims to be dismissed as 'frivolous and vexatious and an 'abuse of the Court process'! Oh, the IRONY!!! Then they take their claim to one of Your bought and paid for judges who enter the decision to dismiss onto the Registry without any judicial oversight from the ACTUAL Ministry of Justice and Attorney General whatsoever!!!

Absolutely BRILLIANT!!! And, You also appear to have a nice little grift going with MHI who steal money from the public Trust account by charging more than they require for rent from Ottawa's People and REFUSE to produce receipts to any of their tenants so they Will never know how much Multifith Housing Initiative is stealing at any Given time!

Of course, You really have thought of everything because I figured a complaint to the LTB would be sufficient to put all these crimes to a stop but You've got the vice chair, William James Campbell colluding with You and endorsing the landlord's theft of public money and ensuring that claim gets dismissed to as not to interfere with their criminal operation. They also tried to have Me evicted TWICE while the complaint was before the tribunal, and all because Your wonderful city of Ottawa employees over at 'Home for Good' routinely cut off subsidy to tenants without notice to them, then LIE and tell the Courts they had right to do so because the individual failed to return renewal forms they don't even bother to send - but they leave that part out in their testimony which of course is fraud under penalty of perjury by Way of omission of evidence with intent to manipulate and pervert justice.

I consider such constructive fraud and conspiracy against Canada's People and their access to justice to be an Act of Treason against Canada's People and the reputation of His Majesty, Charles III.

Any One who does not reply to this email to absolve their self of associate-Sean with these criminals Will be considered aiding and abetting treason against the Crown.

Any reason why the local police haven't made any arrests?
