Good afternoon, Crown for the province of Ontario,

I require the disclosure and screening form for the Beneficiary of the public Trust most commonly known as Sean, House von Dehn. I only checked My spam folder to see if You were still attempting to respond to requests I made to the email address 'virtualcrownottawa@ontario.ca', and IMPERSONATING the official Crown Attorney's office for the City of Ottawa.

I have been advised by the Ministry of the Attorney General and Department of Justice to block this email address for SPAM. They have advised Me this office is engaged in FRAUD and only to Trust emails [from the attached source provided by the Minister of Justice and Attorney General](#).

The 'official' 'VirtualCrownOttawa@Ontario.ca' has not responded to the disclosure request and is 'ghosting' Me? Also, I can't find any Record of these charges on the public Record (Court case look up tool) and (again) it says to contact You if the charges are not showing up on the PUBLIC RECORD (Court case look up tool) within *forty-eight hours*. The case file
