Dear 'Virtual Crown' for the Province of Ontario,

The City of Ottawa has completely compromised both the email intake for the Ottawa Superior Court of Justice and the Ontario Provincial Court of Justice. They have been conspiring with local police to threaten and intimidate Me for attempting to report criminal clerks colluding with City of Ottawa employees at the Ottawa Superior Court to intercept My communications with the Court and ignore My requests for Motions, transcripts, and other documents I was Ordered to receive by Judicial authorities in civil

claim 22-89835. In fact, they have not responded to any of My emails since I first attempted to file a Motion of Contempt to report a couple of corrupt clerks.

It appears all clerks receiving documents for the main email intake for both the Ottawa Superior Court and 'Virtual Crown Ottawa' are serving the City of Ottawa's interests and protecting criminals conspiring against Canada's People, hosting 'private hearings' off the Record at 100 Constellation Avenue. They are trying to convince Me this is perfectly normal.

I require for the attached documents to be forwarded to Superior Court Judge Sally A. Gomery who is familiar with the situation and Will know what to do. I cannot Trust any One in the City of Ottawa, ESPECIALLY the local police.

This has been reported to the executive director of the Ottawa Police Service and *all city councilors* who have thus far failed to take any action or make a single arrest. Documents related to the two fraudulent charges are attached.

I am writing all the Provincial Courts of Justice today and Will be forwarding this email to all the Ontario Superior Courts of Justice tomorrow if I do not receive confirmation from Sally A. Gomery that the attached documents have been received before 5:00 this afternoon.

This degree of criminality and collusion taking place in Canada's Courts is beyond ridiculous - for councilor Cathy Curry and the Executive Director of the Ottawa Police Services to be colluding with them... That's criminal malfeasance and serious breach of the public Trust AT BEST!!!

I look forward to hearing from any Honourable representative of these courts not afraid to Give Me their first and last name for the purpose of accountability, continuity, and liability while We resolve this ridiculous scandal. The corruption of the City of Ottawa is on display for all the world to see, and I am tired of being a victim of their crime and corruption.

Please put the crimes being perpetrated against Me and My deceased father to a stop today.

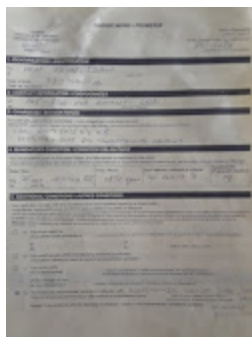
