Mr. von Dehn,

I am contacting you in my capacity as the City Clerk for the City of Ottawa, specifically as relates to the increasing volume and frivolous and vexatious nature of your correspondence to Members of Council.

The City's [Public Conduct Policy](#) serves to promote a respectful, tolerance and harassment-free workplace between all member of the public and staff. The policy contributes to the City's objective of dealing with all residents in ways that are consistent and fair while acknowledging that there may be a need to prospect staff, Members of Council and residents of the City of Ottawa from unreasonable behaviour and frivolous and/or vexatious actions.

Over the last several weeks, you have sent Members of Council numerous voluminous e-mails ranging from allegations of wrongdoing to demands for intervening in your legal matters and paying you large sums of money. It is my view that your correspondence meets the definition of frivolous and/or vexatious requests, as set out under the Public Conduct Policy.

In keeping with the requirements of the Public Conduct Policy, my Office consulted with the Integrity Commissioner on this matter and can advise that I have instructed Members and their staff to not respond or acknowledge your correspondence on these matters. More specifically, Section 3 of the Public Conduct Policy provides as follows:

**Potential Restrictions:** Restrictions should be tailored to deal with the specific circumstances. **Actions available to the General Managers to restrict the individual may include**, but are not limited, to **any one or combination of the following**:

- a. Limiting the individual's correspondence with staff to a particular format, time or duration;
- b. Limiting the individual to a particular point of contact;
- c. Requiring any face-to-face interactions between the individual and staff to take place in the presence of another staff member;
- d. Requiring the individual to make contact with the City only through a third party, such as a solicitor or counsellor;
- e. Limiting or regulating the individual's use of City services;
- f. Refusing the individual access to a City facility except by appointment or specific permission;
- g. Requiring that the individual produce full disclosure of documentation or information before staff will further investigate a complaint;
- h. Instructing staff not to respond to further correspondence from the individual regarding the complaint or a substantially similar issue;**
- i. Informing the individual that further contact on the matter will not be acknowledged or replied to;**
- j. Closing the complaint or request for service;

- k. Instructing staff not to investigate any complaints regarding an issue that has already been investigated or which is substantially similar to an issue that has already been investigated;
- l. Instructing staff to severely reduce or completely cease responses to further complaints or request and correspondence from the individual;
- m. Pursuing legal action including issuance of a Notice of Trespass in accordance with the Corporate Trespass to Property Procedures.

I take these steps with the greatest reluctance, but your continued pursuit of this frivolous allegation leaves me no alternative.

Dear Mr. Caitlin Salter-MacDonald,

I perceive Your letter to be an additional act of contempt with intent to threaten and intimidate Me for reporting federal crimes of Court fraud and crimes against humanity for harmful, mandated medical products in violation of international Law and Nuremberg Principles regarding informed consent.

You, and every other city councilor in the City of Ottawa were placed on Notice of Civil and Criminal Liability for Obstruction of Justice, Fraud, Impersonating Provincial Crown Attorney to proceed against individuals in fraud and with the purpose to intimidate and harass, mandating dangerous medical products in violation of Canada's Charter section 7, crimes against humanity, and depriving Me of access to Justice (failing to forward My emails to Superior Court Judge Sally A. Gomery so that I can report the fraud to a competent Judicial authority).

Responding to such notices with additional fraudulent police information, sending police to My apartment to intimidate Me for reporting to Cathy Curry is further criminal negligence causing harm and contempt. I have all the evidence necessary to prove Your fraud and I have on many occasions provided such evidence in My emails to You.

I advised You that I have reported federal, indictable offences, and continual trespass upon My Spiritual beliefs and convictions expressed in a Trust on Record with MOJAG. You have routinely been advised that 'Mr.' is a position of office, One I find deeply offensive and distinctly different from 'King', which is My natural legal status as a Sovereign Man in a Constitutional Democratic Monarchy where consent of government is derived by the consent of the People. I believe You are engaged in Crimes against humanity, and I now believe it is with intent because it is not believable to Me that You believe this degree of 'gaslighting' by state actors is acceptable.

The purpose of sending the emails to every Provincial Court in the Province including the Provincial Court in Ottawa which You continually 'impersonate' in fraud through an email address, '[virtual.crownottawa@ontario.ca](mailto:virtual.crownottawa@ontario.ca)' which the Ministry of the Attorney General and Department of Justice have advised Me to ignore for FRAUD. The Ministry of the Attorney General's office is Superior to You, You have no right or authority whatsoever to be addressing and threatening Me AGAIN after Stuart the Hopeless Huxley was JUST advised of same in another NOTICE of Criminal Liability for Your contemp and failure to respond to emails which every single one of You have a legal

and lawful obligation to respond to as Trustees of the public Trust and the artificial legal person You Created in the likeness of My calling without My informed consent.

You have not responded to any of the attached emails, and as I advised Stuart the Hopeless Huxley, failing to respond is an Act of contempt and constitutes additional (and very serious) breaches of the public's Trust. Until You are ready to arrest the Kreling Criminal Cabal obstructing My access to Justice for 22-89835 and explain why You continue to mandate a medical product that has been shown to cause the disease it was designed to prevent if Your intent is not to cause harm, You are considered a party to these crimes and liable in Your personal, private capacity.

I can't help but wonder if You are related to Kimberly MacDonald, the City of Ottawa employee who continues to collude with corrupt cops and City of Ottawa employees to send Me fraudulent informations from '[virtual.crownottawa@ontario.ca](mailto:virtual.crownottawa@ontario.ca)', an entirely bogus email address set up exclusively to engage in fraud and impersonate the Ontario Provincial Crown Attorney's Office. Is she Your daughter? Is Gillian the Criminal Kreling the daughter of Justice Herb Kreling? Is this why City of Ottawa employees and the police are colluding with them rather than arresting them for their fraud and obstructing My access to Justice?

If You are NOT guilty of obstructing My access to justice and not complicit with the Kreling Criminal Cabal, You Will forward My emails to Superior Court Judge Sally A. Gomery TODAY, or You Will be considered complicit not only in obstructing My access to justice, but for failing to respond to Notices of Civil and Criminal Liability for mandating a medical product that the Cleveland Clinic Study has shown to cause more harm than Good to Canada's People.

Continuing to remain silent and not alert Canada's People to the Cleveland Study and the serious adverse events of the medical product You, coerced, intimidated and mandated on Ottawa's People falsely telling them the product is 'safe and effective' when We now know they were anything BUT 'safe and effective'.

Your contempt in response to My very urgent emails solidifying My conviction that You are engaged in criminal conduct and that Your INTENT is to deceive Canada's People in order to sell as many dangerous medical products as You can, regardless the harm done to Canada's People.

Once again, this constitutes crimes against humanity, and I have filed a complaint with the International Criminal Court of Justice because I am tired of emails like Yours this morning that do not answer a single question I've been as King (gaslighting the real issues), while telling Me the Notice is inappropriate and that a Notice of Criminal Liability for obstructing My access to Justice and crimes against humanity for mandating a medical product estimated to cause 1037 fetal infant deaths in pregnant mothers while You kept this information secret, continuing to advise pregnant and nursing mothers that the vaccines were 'safe and effective'.

You consider this a responsible and appropriate reply to such notices? You believe these crimes and complaints and 'frivolous and vexatious'? You may be the stupidest, most incompetent of them all and You are hereby Given Notice of

Default Judgment, Nihil Dicit, Res Judicata for Crimes Against Humanity, Obstruction of Justice, Criminal Breach of Public Trust and Malicious Collusion and Conspiracy to Trespass upon an Express Trust on file with MOJAG with intent to antagonize.

This email and any further replies Will be added to My Claim with the International Criminal Court of Justice.

Do You believe that Your letter is an appropriate reply to the attached documents? You have a legal and lawful duty and fiduciary obligation to respond to a Notice of Civil and Criminal Liability APPROPRIATELY addressing each of the points in My Notices or the Common Law presumes You are GUILTY AS CHARGED!!!

I am not going to continually teach You the Rule of Law in a Constitutional Democratic Monarchy, You are expected to know how to respond to a Notice of Liability appropriately and Your recent emails demonstrate contempt, incompetence, and or collusion to double down on Your crimes.

You are hereby served and may be lawfully removed from Your position of office for tacitly conceding to such serious charges.

This also constitutes emotional and psychological abuse because Your emails are clearly not being sent to resolve any of the issues, but to gaslight, avoid accountability, and threaten Me with further harm. Again, I Will not tolerate it.

You Wish to charge Me, go ahead - but make sure You process Your documents onto the Registry this time so as not to avoid oversight from MOJAG, using the Courts as a cloak for Your fraud.

The reason these emails are sent to every provincial Court of the Province is so that if I were WRONG about Your fraud, one of the official court offices for the Ontario Provincial Court could provide the Court of Record for Your fraudulent hearing to absolve You of these accusations - no such thing has been done because I know You're using the Provincial Courts as a cloak for Your fraud because **the Minister of Justice advised of as much and told Me to disregard Your emails.**

If You don't Wish to be included as complicit in these charges, You Will make sure that I hear back from trial coordinator Sally A. Gomery so that the individuals attempting to steal My inheritance by using Your Courts as a cloak for their fraud can be apprehended. I Will not quit until My deceased father has had his day in Court and is absolved of all the false allegations made against him by further fraudulent filings received by Jove the Predator Ponniah of the Toronto Superior Court of Justice. Understood?

This Notice and the charges contained therein applies to all individuals in receipt of these emails.

You Will find the third and FINAL NOTICE OF CRIMINAL AND CIVIL LIABILITY for CRIMES AGAINST HUMANITY, CONTINUOUS CONTEMPT AND EGREGIOUS BREACH OF PUBLIC TRUST ATTACHED.

YOU ARE NOW NOTED IN DEFAULT JUDGMENT, 'NIHIL DICIT' (because this email also 'says nothing' in reply to any of the serious issues I am as King of You to address), 'RES JUDICATA' - decision is final because You have had ample opportunity to provide a REASONABLE and CORRECT reply, but have failed to do so and continue to harass, antagonize, economically exploit Me, and threaten Me with further harm.

I should not have to tell You this is not acceptable. You and every One in receipt of this email or the Supervisor of the Provincial Court of Justice in receipt of these emails can lawfully be removed from office, You are now holding Your position 'de-facto'. You are a criminal abdicating Your Oath to the Crown and Canada's People.

You are hereby served. Please also note that My Oath to His Majesty is on Record with MOJAG, and trespass upon a Governor General to His Majesty is an Act of High Treason in Canada. You are hereby charged with high treason in addition to the other charges listed in this email.


Send these emails to Sally A. Gomery and if the Honourable Superior Court Judge concurs that Your email is an appropriate reply, I Will deal with Sally A. Gomery in the Divisional Court of Justice. Sound fair?
