Good evening, Dean,

I'm giving My adversaries in Law a break today, though I Will Post something to My Blog later tonight. I also made a complaint to the Law Society of Ontario including as many of the lawyers involved as possible, though there wasn't enough room in the complaint to list them all on the online form.

The fraud involved three Superior Courts; Ottawa, Bracebridge and Toronto, and Court supervisors Gillian Kreling, Carrie Thompson, and Jove Ponniah respectively. They are effectively obstructing all My attempts to file documents and bring motions before the Court.
