Good morning, 'Virtual' Crown,

Well, 'Virtual' is certainly one Word for it, isn't it? Incompetent would be more appropriate if We are going to be honest about anything.

This is a Common Law Jurisdiction. The Common Law presumes that every One in receipt of this email is governed by conscience, reason, and logic. The Common Law presumes that any One with a moral or ethical obligation to respond to My email Will do so. The Common Law presumes that if One does NOT reply, it is because they have

'nothing to say', Nihil Dicit (He says nothing - Maxim in Law) as any One with a moral or ethical obligation to respond Will do so if only to defend One's *Honour*.

This is My third email to this Court. The first email was marked URGENT, UNDER DURESS, and I explained that I am Writing every Provincial Court in the province because criminals posing as public servants for the City of Ottawa have hijacked the Virtual Crown Ottawa email address, and are impersonating provincial Crown to proceed against Canada's People in fraud and in violation of every Rule of the Court and Principle of Justice necessary for a fair and public hearing!!!

I advise You that I have reported this to every single City councilor in the City of Ottawa, the Mayor of Ottawa, and the Ottawa Police Service, and every single one of these individuals have instead helped to protect these criminals posing as public servants, rather than file a police report and start making arrests.

Cathy the Colluding Curry is a member of the Ottawa Police Service and Promised Me she would forward My emails to Habib A. Sayah, despite the fact she was told I can't Trust the police because they are part of the problem - it was Ottawa Police officers Dawn the Delinquent Neilly and Kimberly the Deplorable Duggan the instigated the fraudulent charges, conspiring with several clerks of both the Ottawa and Toronto Courthouse to continue perpetrating the fraud. Rather than make any arrests when the corrupt officers were reported to Habib A. Sayah and provide Me with assurances that the criminals conspiring against Me would be removed from the force and prosecuted as any other Man in a Common Law jurisdiction would expect to be charged if they violated their Oath with criminal intent, he sent four more goons to My house.

Instead, Habib A. And not One individual in receipt of this email Wished to respond to an URGENT message with S.O.S. in the subject line? Was it not clear enough that I am under extreme duress and in trouble? Or You just don't care?

The Common Law presumes You just don't care.

Kim MacDonald volunteers a fraudulent copy of what she calls the 'Certified True Copy' of the Court of Record for 23-353404 and You STILL don't have enough evidence to start making arrests?

And You expect Me to believe that every Court in the Province of Ontario has not been compromised by the City of Ottawa's criminal cabal? This email went out to over eighty

provincial Courts in the province. Not ONE individual in eighty provincial Courts across the province has sufficient moral integrity to even respond to Me? Not One city councilor in the City of Ottawa even bothers to reach out to Me to express their regret and condolences? This is 'normal' behaviour for the Ontario Court of Justice and their clerks?

You were also advised that if I did not receive a reply yesterday that every Supervisor for every email address in receipt of this email would be charged with one count of breach of public Trust for every day I do not receive a reply, and that I Will be as King to have those supervisors removed from their position when Justice finally prevails.

Once again, there was no reply, and therefore no protest to My terms and conditions, so You have tacitly conceded that all Supervisors in receipt of this email are now guilty of one count of breach of Trust, and that Will compound for every day the silence continues.

This is a WARRANT for the arrest of Kimberly MacDonald, Vinicius the Odious Oliveira, Yvonne the Grifting Goebel, Dawn the Delinquent Neilly, Kimberly the Deplorable Duggan, and Habib the Stupid Sayah who is weaponizing his officers against Ottawa's citizenry in violation of his oath. I also consider that to be an Act of Treason considering the serious nature of his Trusted position of office.

Any who do not reply to Me today Will be presumed complicit in this Act of Treason against Canada's People, obstructing their access to justice with malicious intent to rob Canadians of their right to due process and Constitutional protections they are Promised by these Courts.

Okay. Well, the Common Law presumes You can all read English. The Common Law presumes if You don't reply You have 'nothing to say' in defense of the charges against You.
