## Notice of Criminal Liability: Targeted Abuse, Discrimination, Breach of Trust

Whereas Wendy Stephanson serves as Council's *chief administrator leading the organization to deliver services across more than 100 distinct lines of business through nine departments, three offices and 17,000 employees.*

and whereas the Manager is responsible and therefore liable for the Acts of the 17,000 agents Trusted to serve Canada's People in the City of Ottawa,

and whereas the Ontario Superior Court of Justice and the Ontario Provincial Court of Justice in the city of Ottawa are obstructing access to Justice to protect the City of Ottawa's interests, a serious, federal offense and breach of public Trust,

and whereas these agents of the City of Ottawa colluding against Canada's People have been reported to the City of Ottawa's local police, and the police are colluding and conspiring with City of Ottawa employees to harass and intimidate a Claimant before the Superior Court of Justice, aiding and abetting the City of Ottawa's obstruction of Justice,

and whereas City of Ottawa employees Trusted to responsibly manage provincial funds for Canada's Beneficiaries via the Ontario Works Act are trespassing upon a Trust on file with MOJAG with impunity because the police support and endorse their crimes, causing them to develop the insane ideology that the Trustee Act of Ontario and Canada's Criminal Code is not binding upon the public Trustee for malicious breach of a Trust Instrument,

and whereas You are responsible for setting up a 'Home for Good' program that conspires with not for profit organization, Multifaith Housing Initiative to coerce and intimidate tenants receiving subsidy into receiving an unnecessary medical product posing as a vaccine which has proved to do more harm than Good to Canada's People, steal more money than they are authorized to take, withhold receipts for rent from tenants to cover over their fraud, fail to provide lawful notice of entry before entering a unit, and conspire with the Landlord Tenant Board tribunal Chair, James William Campbell to ensure that reporting these crimes to the LTB Will be dismissed as presenting 'no justifiable cause of action', presumably because James William Campbell is receiving a share of the profits from their scam,

and whereas these crimes and those of Housing Services, Ontario Works, the City of Ottawa's lawyers, Genevieve Langlais and Samantha Montrieul are Your liability as

manager for the City of Ottawa,

and whereas it is only natural to presume that as the city of Ottawa Council's *chief administrator leading the organization to deliver services across more than 100 distinct lines of business through nine departments, three offices and 17,000 employees, You are ultimately liable for the over \$100,000,000.00 I am entitled to in damages for the harm done to Me by Your criminal cabal posing as public servants,*

*You, Wendy Stephanson are liable to King Sean, House von Dehn, for the full Value of Claim 22-89835 for obstructing My access to justice, interfering with My ability to report these crimes to a competent judicial authority, threats and intimidation by local police when attempting to report the criminals working for Your organization, and the gross, criminal contempt for the Rule of Law that seems to permeate Your entire City. Your lawyers and police are defending indictable, federal offenses perpetrated by agents of Your organization, and You are presumed to be the head of this cabal.*

In Canada when One is harmed by a group of individuals conspiring together, each of the tortfeasors are jointly and severally liable, and the Claimant who is wrong done by may be as King of any of the tortfeasors to fulfill the full Value of the Claim,
